

The Richlands Board of Aldermen met in regular session on Tuesday, March 21, 2017, at 6:00 pm in the board room at the Richlands Town Hall. Present for the meeting were:

### I. <u>MEETING CALLED TO ORDER:</u>

Mayor McKinley Smith called the meeting to order at 6:00 pm.

### IV. ADOPTION OF AGENDA:

Gregg Whitehead, Town Administrator, presented the agenda to the Board.

A **motion** was made by Alderman Kandy Koonce, seconded by Alderman Michael Carpenter to adopt the agenda as presented. The motion was unanimously carried.

### V. APPROVAL OF MINUTES (February 14, 2017):

A **motion** was made by Alderman Paul Conner, seconded by Alderman Kandy Koonce to approve the regular board meeting minutes of February 14, 2017. The motion was unanimously carried.

### VI. PUBLIC COMMENTS

### **Heather Wolf:** 287 Northwest Bridge Road, Richlands

Mrs. Wolf commented on her concerns with the lack of bathroom facilities in Venter's park and requested to have the issue addressed and taken seriously by the Board. Mrs. Wolf stated that so much time and funds have been put into the park and that it is very nice. She provided the Board with a quote from Blu Site Solutions, which is incorporated by reference and hereby made part of these minutes. The quote was a monthly fee of \$80.70.

### IX. NEW BUSINESS:

### 1. Schedule Public Hearings:

### A. Conditional Use Request (A Marie Carr, 113 Dreadnaught):

Mr. Whitehead stated that Ms. A. Marie Carr is seeking a Conditional Use Permit to install a Class B manufactured home at 113 Dreadnaught St., which requires a public hearing. Mr. Whitehead requested for the Board to schedule a public hearing.

A **motion** was made by Alderman Kandy Koonce, seconded by Alderman Michael Carpenter to schedule a public hearing on April 11, 2017 at 6:00 pm to hear public comment regarding the Conditional Use Request for 113 Dreadnaught St. The motion was unanimously carried.

### B. Conditional Use Request (Donald Smith, 212 Woodson St):

Mr. Whitehead stated that Mr. Donald Smith is seeking Conditional Use to operate a barber shop in his home at 212 Woodson St. Mr. Whitehead stated that this request requires a public hearing and asked the Board to schedule one during the next board meeting.

A **motion** was made by Alderman Paul Conner, seconded by Alderman Kent Painter to schedule a public hearing on April 11, 2017 at 6:00 pm to hear public comment regarding Mr. Smith's Conditional Use Request for a barber shop in his home at 212 Woodson St. The motion was unanimously carried.

### C. Proposed Zoning Text Amendment Ordinance 2017-01 (School Signs):

Mr. Whitehead presented Ordinance 2017-01 to the Board. This ordinance is to amend the current Richlands Zoning Ordinance Title XV, SECTION 1. That the Richlands Board of Aldermen repeals Title XV, Section 153.107, paragraph (B), sentence (6) of the Richlands Code of Ordinances and inserts a new Section 153.107, paragraph (B), sentence (6) to read as follows:

"Public and private schools signs shall follow the regulations as outlined in §§ 153.180 through 153.192. However, free-standing signs located along public right-of-way shall be limited to ground signs as prescribed in §153.187 (E)."

Mr. Whitehead stated that this also requires a public hearing to be scheduled prior to approval.

A **motion** was made by Alderman Michael Carpenter, seconded by Alderman Kandy Koonce to schedule a public hearing regarding Ordinance 2017-01 Zoning Text Amendment for April 11, 2017 at 6:00 pm. The motion was unanimously carried.

### D. Property Purchase Request (Mr. Daryl Burgess):

Mr. Whitehead reported that he has received a request from Mr. Daryl Burgess to purchase town owned property located off of W. Hargett St. behind the Yaneeda Plaza building. This property is tax parcel #201-155 and has an old abandoned well site on it. Mr. Whitehead explained that town owned real property cannot be directly sold to a private party and that it would have to be declared surplus by resolution and go up for public bid. Mr. Whitehead also reported that he and Mr. Jarman located two property deeds, one dated 1920 from the Grouses and another one dated 1936 from Rand Oil. Attorney Keith Fountain stated that much more research would need to be done to determine setbacks, surveys, property value, etc. before deciding whether or not to sell. Mr. Burgess was present and stated that he currently owns the property adjacent to this one and expressed his desire to purchase it and clean it up.

After discussion, **a motion** was made by Mayor Pro Tem Tom Brown, seconded by Alderman Kent Painter directing Town Administrator, Gregg Whitehead and Town Attorney, Keith Fountain to do diligence and further research Tax Parcel #201-155 and bring results back to the board when completed. The motion was unanimously carried.

### X. <u>ADMINISTRATOR NOTES AND UPDATES</u>:

The Town Administrator, Gregg Whitehead, presented a copy of notes and updates to the Board which is incorporated by reference and hereby made part of these minutes. Mr. Whitehead also reported on the following:

- > Town Hall Day is next Wednesday, March 29<sup>th</sup>, 2017. Mr. Whitehead will be attending and invited the board members to join him.
- ➤ Requested to have a Public Safety Committee meeting scheduled within the next couple of weeks. The Town Clerk will contact committee members to schedule.
- Mr. Whitehead stated that he has done some research on placing a porta potty at the park. If the Board would like for us to address this issue, we can during the budget workshop.

A **motion** was made by Mayor Pro Tem Tom Brown, seconded by Alderman Michael Carpenter directing Town Administrator, Gregg Whitehead, to research solutions regarding the bathroom situation in Venters Park and bring results back to the Board when completed. The motion was unanimously carried.

Chief Ron Lindig presented the Police Activity Log for the month of February, 2017, which is incorporated by reference and hereby made part of these minutes. Chief Lindig also reported on the following:

➤ Chief Lindig reported that on Wednesday, March 21, 2017, he and Mr. Jarman will be picking up a medicine drop box from the SBI. It will be installed in the town hall lobby and bolted to the floor. We will collect the medications that are dropped off and the SBI will pick them up and destroy them. Alderman Kent Painter requested the Police Department to contact the local pharmacies in town and make them aware of the medicine drop box in town hall.



Zoning Text Amendment Ordinance (2017-01)

### **Description:**

Richlands Zoning Ordinance Text Amendment (Ordinance 2017-01).

#### **Review:**

Now that the appropriate public hearing has been held, the Board may deliberate and vote on Ordinance 2017-01. The ordinance will amend the zoning text to remove the current restriction that free standing signs for schools located in a residential district be limited to 32 square feet in size. The new zoning text will allow schools to have the same size free standing sign as those allowed in the commercial districts. However, free standing school signs will be limited to monument signs as opposed to pole mounted signs.

The Richlands Planning Board has reviewed the request and voted unanimously to recommend approval of the request to the Board of Aldermen.

### ORDINANCE 2017-01

### Ordinance Amending Official Richlands Zoning Ordinance

Introduced: March 21, 2017 Adopted:
WHEREAS, the Town of Richlands (hereinafter Town), recognizes some unnecessary language in the certain sections of Chapter 153 ZONING of the Richlands Code of Ordinances, specifically the section pertaining to sign regulations for public and private schools; and
WHEREAS, the proposed Text Amendment has been reviewed and deemed appropriate by the Richlands Planning Board; and
WHEREAS, the Richlands Board of Aldermen has posted the required notice and a public hearing for the proposed Text Amendment was held on, 2017; and
NOW, THEREFORE, BE IT ORDAINED:
SECTION 1. That the Richlands Board of Aldermen repeals Title XV, Section 153.107, paragraph (B), sentence (6) of the Richlands Code of Ordinances and inserts a new Section 153.107, paragraph (B), sentence (6) to read as follows:
Public and private schools signs shall follow the regulations as outlined in §§ 153.180 through 153.192. However, free-standing signs located along public right-of-way shall be limited to ground signs as prescribed in §153.187 (E).
SECTION 5. All existing ordinances or parts of ordinances in conflict with this ordinance are hereby repealed to the extent of such conflict.
SECTION 6. If any section, subsection, paragraph, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed severable and such holding shall not affect the validity of the remaining portions hereof.
SECTION 7. This ordinance shall be effective immediately upon its adoption.
